CITY OF HELEN COMMISSION MEETING OCTOBER 8, 2019 MINUTES OF MEETING

The Helen City Commission met on Tuesday October 8, 2019 in the Commission Chambers at Helen City Hall with Mayor Cinnamon Spurlock calling the meeting to order at 10:00 a.m.

ROLL CALL BY CITY CLERK MARILYN CHASTAIN; Present were Mayor Cinnamon Spurlock, Commissioner Jeff Ash, Commissioner Steve Fowler and Commissioner Geneva Elwell. Absent was Commissioner Lee Landress.

Also attending were City Manager Jerry Elkins, City Attorney Carl Free, City Clerk Marilyn Chastain, Finance Officer Mona Wood, Police Chief Brian Stephens, Fire Chief Jody Prickett, Public Works Director Ross Hewell, and Building & Zoning Director Darrell Westmoreland.

PLEDGE OF ALLEGIANCE TO THE FLAG

City Clerk Marilyn Chastain had the honor of reading a list of accomplishments of City Manager Jerry Elkins and the City presented him with a wall clock as a token of their appreciation for 20 years of service. Present for the surprise presentation were many friends, family, employees, department heads, and Commission members past and present. There was a reception following the meeting.

PETITIONS AND COMMUNICATIONS FROM THE PUBLIC; Chris Seymour of Alpine Carriage Company asked the Commission to reconsider not allowing the Carriages to park on River Street as they have done for 19 years. He stated there had been no accidents involving the carriages and there were no other places to park. He went on to say that there is some smell from the urine, but that they do disinfect and wash down the area, and that the horses are a big draw to the town and to please reconsider that this is many of their lively hoods and is for their workers as well.

Craig Sowerby of Pegasus Carriages also asked the Commission to reconsider not allowing the carriages to park on River Street to pick up fares that he has been in the Carriage business for 17 years in Helen. He then asked the Commission to explain why they had voted on this. Commissioner Steve Fowler stated he had made the motion to acknowledge the congestion of traffic and being unsafe because of the added number of people in the area. Mayor Cinnamon Spurlock stated there is no cross walk there leading to the public restrooms and also thinks it is a safety issue after talking with department heads and that utilizing City property for private industry has caused complaints. Commissioner Steve Fowler also stated he has no problem with the route just the parking on City property. Mr. Sowerby asked about using the City property on Dye Street and was told that is also City property and or DOT right of way and could not be used.

Connie James of Hornes Buggy Rides stated she understands the safety concerns but would like for the Commission to hear and consider solutions such as possibly cutting down on the number of carriages allowed.

Chris Seymour stated to per the current city ordinance there are 2 areas that can be used for loading and unloading. City Manager Jerry Elkins stated that is true until January 1^{st,} at which time the Ordinance will be changed prior to that date.

Misty Gilbert stated she has driven for everyone of the Carriage Companies and hopes the Commission will reconsider letting the carriages keep using the area.

A. Fletcher Holiday explained the new well is producing approximately 52 gallons of water per minute but that testing shows that there is a fracture at 197 feet, and shows silt coming into the well, that to put a temporary packet to seal the leak may cure the problem and if it did then a permanent packet could be installed. He stated that there is an 85% chance that it will be successful. However, that because of funding from the state and federal levels there are certain guidelines that must be followed. If it is decided not to try the packet this would result in the well being useless and any money that has been spent so far would be lost. Commissioner Steve Fowler made a motion to go ahead with the temporary packet, 2nd by Commissioner Jeff Ash. Motion approved with a unanimous vote of the Commission present.
