# CITY OF HELEN COMMISSION MEETING APRIL 20, 2021 MINUTES OF MEETING

The Helen City Commission met on Tuesday April 20, 2021 in the Commission Chambers at Helen City Hall with Mayor Lee Landress calling the meeting to order at 10:00 a.m. City Clerk Marilyn Chastain called the roll and attending were Commissioner Jeff Ash, Mayor Lee Landress, Commissioner Steve Fowler, and Commissioner Fred Garmon and Commissioner Geneva Elwell.

Also attending were Finance Officer Mona Wood, City Manager Jerry Elkins, City Attorney Carl Free, City Clerk Marilyn Chastain, Police Chief Brian Stephens, Fire Chief Jody Prickett, Public Works Assistant Director Jack Morgan, Building & Zoning Director Darrell Westmoreland.

#### PLEDGE OF ALLEGIANCE TO THE FLAG

APPROVAL OF AGENDA; Motion to approve made by Commissioner Jeff Ash, 2<sup>nd</sup> by Commissioner Fred Garmon. Motion approved with a unanimous vote of the Commission.

#### ADMINISTRATIVE OPERATIONS

PETITIONS AND COMMUNICATIONS FROM THE PUBLIC MICHAEL HAMMERSMITH TO DISCUSS POSSIBLE ZONING CHANGE OF COMER CIRCLE PROPERTY; Not present, no discussion.

Craig Sowerby stated he had purchased lot 21 in the Island and wanted permission to cut an apron in the curbing for an entrance to his property. Building Director Darrell Westmoreland explained the requirements. Motion to approve made by Commissioner Steve Fowler, 2<sup>nd</sup> by Commissioner Jeff Ash. Motion approved with a unanimous vote of the Commission.

Cinnamon Ruston asked if the City had considered pay parking in the Island area.

There was discussion of possible zoning changes to the lots in the Island due to lack of parking from possibly C2 which it is now zoned to R4 which would be parking underneath with living quarters overhead. City Attorney Carl Free stated that the Georgia procedures Act of proposed changes requires public hearings, newspaper notices and other requirements before zoning is changed. Commissioner Steve Fowler made a motion to gather information then call for a work session to include property owners that would be affected, 2<sup>nd</sup> by Commissioner Geneva Elwell. Motion approved with a unanimous vote of the Commission.

HELEN/WHITE COUNTY CVB MONTHLY REPORT; Director Jerry Brown was present and gave a verbal report. Report included as an integral part of the Minutes. Director Jerry Brown stated he had found someone to preform 3 days per weekend during Oktoberfest in the Band shell at a cost of \$230.00 per day, or \$690.00 per week. Commissioner Jeff Ash made a motion to approve \$230.00 per day up to a total of \$4,000.00 during Oktoberfest under the authority of the City Manager, 2<sup>nd</sup> by Commissioner Steve Fowler. Motion approved with a unanimous vote of the Commission.

There was discussion of purchasing hat pins for the 51<sup>st</sup> Oktoberfest and discussion of the Helen Chamber of Commerce selling 50<sup>th</sup> anniversary pins which were bought last year during Covid. Commissioner Steve Fowler stated he thinks it is ok to have both that the Chamber is a private business and can sell what they choose.

POLICE DEPARTMENT MONTHLY REPORT; Police Chief Brian Stephens was present and gave a verbal report. Report included as an integral part of the Minutes. Commissioner Jeff Ash asked Chief Stephens to explain recent calls to a party at a rental in Innsbruck. Chief Stephens stated they had responded 3 times to a party over the weekend at a rental home in Innsbruck of noise complaints and parking in private driveways. Chief Stephens explained the Police Department cannot enforce homeowner association rules. Commissioner Jeff Ash asked the Chief to notify the Innsbruck Homeowner Association President of recent problems at rental units in Innsbruck.

FIRE DEPARTMENT MONTHLY REPORT; Fire Chief Jody Prickett was present and gave a verbal report. Report included as an integral part of the Minutes.

PUBLIC WORKS, WATER AND WASTE WATER MONTHLY REPORT; Assistant Public Works Director Jack Morgan was present and gave a verbal report. Report included as an integral part of the Minutes.

BUILDING AND ZONING MONTHLY REPORT; Building Director Darrell Westmoreland was present and gave a verbal report. Report included as an integral part of the Minutes. Building Director Darrell Westmoreland stated the manager of the Hayloft had asked for a second open sign for the other side of their building that faces another City Street and that it had been approved for other businesses prior.
