The Helen City Commission met on Tuesday February 7, 2017 in the Commission Chambers at Helen City Hall with Mayor Helen Wilkins calling the meeting to order at 10:02 a.m.

Deputy Clerk Debbie Gerchman called the roll and the following were present: Commissioner Cinnamon Spurlock, Commissioner Fred Garmon, Mayor Helen Wilkins, Commissioner Judy Holloway, and Commissioner Jeff Ash.

Also attending were City Manager Jerry Elkins, City Attorney Carl Free, Deputy Clerk Debbie Gerchman, Police Chief Brian Stephens, Public Works Director Ross Hewell, and Building & Zoning Director Larry Krul. Fire Chief Jody Prickett was present before the meeting but was called out on an emergency call.

- B. APPOINTMENT BY CITY COMMISSION OF 3 MEMBERS TO THE PLANNING, DESIGN, AND REVIEW BOARD: Motion was made by Commissioner Judy Holloway to approve the appointment of Linda McAllister to fill the vacant spot on the Board and extend the term an extra year. Seconded by Commissioner Fred Garmon. Commissioner Jeff Ash made a motion to approve the appointments of David Greear and Catherine Cleiman, seconded by Commissioner Cinnamon Spurlock. Motions approved with a unanimous vote of the Commission. Building & Zoning Director Larry Krul stated that there were going to be two more seats available in March.
- C. APPROVAL TO SET ARBOR DAY EVENT FOR FEBRUARY 17TH AT 11:30 A.M.: The Commission agreed to the date and time for the Arbor Day Event. City Manager Jerry Elkins stated that this year they would be planting and replacing damaged trees in the Island Area.

- F. REVIEW OF UPCOMING CITY PROJECTS: City Manager Jerry Elkins presented the Commissioners with a list of upcoming Capital Projects for 2017. The list of projects will be included as an integral part of the minutes. Mr. Elkins discussed funding for the projects, which included City revenues and Grant revenues. He stated Commissioner Fred Garmon will be in charge of the Fire Department Addition. The Chattahoochee Sewer Line project will be delayed until the end of the year and then will be re-evaluated. Commissioner Helen Wilkins and Commissioner Jeff Ash thanked Mr. Elkins for all his hard work and time he puts in getting Grants for the City.

- 10. PUBLIC WORKS, WATER AND WASTE WATER OPERATIONS: Public Works Director Ross Hewell stated that everything is on schedule and that they were getting ready for Spring.
- 11. BUILDING AND ZONING OPERATIONS: Building and Zoning Director Larry Krul stated that Wildeforest would probably be completed in about another month to a month and a half; that he has cleared the first three floors at Valhalla Resort Hotel; that the Fairfield Inn has finished the retaining wall.

A. CONSIDERATION FOR APPROVAL OF BID FOR ESCOWEE STREET SIDEWALK PROJECT: City Manager Jerry Elkins stated that the City had received two bids for the project. The prices received were with the City buying the concrete for the project. The first bid was from Wilkinson Concrete for \$39,447. The second bid was from JDCon, Inc. for \$32,308. Commissioner Fred Garmon made a motion to approve the bid from JDCon, Inc., seconded by Commissioner Jeff Ash. Motion was approved by a unanimous vote of the Commission.
