C. Discussion of Sewer Line Improvement on Chattahoochee river bank; City Manager Jerry Elkins stated that as the Commission already knows that in order to access the sewer line for improvements, access would need to be granted from the property of Merle Long, and that Mr. Long has stated to Building & Zoning Director Larry Krul that he would consider letting the City access the sewer line from his property if the City would install additional curb cuts in the proposed sidewalk to his property on Escowee from the original proposed plans of 96 feet of curb cuts, to 240 feet of curb cuts proposed by Mr. Long. A copy of the additional proposed curb cuts are included as an integral part of the permanent minutes. Commissioner Dona K Burke stated that the two projects are not relative to each other. After much discussion, Commissioner Jeff Ash made a motion to decline Mr. Long's offer of the City installing additional curb cuts in the new sidewalk at his property on Escowee and not do the project on the Sewer line improvement at this time, 2nd by Commissioner Dona K Burke. Motion approved with a unanimous vote of the Commission present.
