The Helen City Commission met on Tuesday May 2, 2017 in the Commission Chambers at Helen City Hall with Mayor Helen Wilkins calling the meeting to order at 10:00 a.m.

ADMINISTRATIVE OPERATIONS

A. CONSIDERATION OF PURCHASING A DIESEL TOWABLE AIR COMPRESSOR, 90 LB HAMMER, AIR HAMMER AND BITS FROM NEFF RENTALS. B. DISCUSSION OF FUNDING FOR THE HELEN ARTS AND HERITAGE CENTER THAT WAS TABLED FROM THE APRIL 18, 2017 COMMISSION MEETING; After some discussion, Commissioner Fred Garmon made a motion to approve funding \$30,000.00 to the Arts Center for 1 year, 2nd by Commissioner Jeff Ash. The remaining Commissioners were not in favor of funding until further information on the Center's budget could be provided.

After more discussion Commissioner Fred Garmon withdrew his motion until more of the research information requested from the Arts Center is obtained, and until after looking at the City's upcoming new budget for 2017/2018 is considered.

POLICE DEPARTMENT OPERATIONS; Police Chief Brian Stephens informed the Commission of an upcoming Identity Theft and Security Internet Awareness class he will be conducting on May 8th at City Hall for local citizens and that he will conduct more of this type classes during the summer months. He then informed the Commission of minor damage to 2 of the patrol cars.

FIRE DEPARTMENT OPERATIONS; Fire Chief Jody Prickett stated he is still finishing up on needed items for the ISO rating and informed the Commission of a house fire in the City on Hex Strasse. He stated that due to the sharp turn getting to the fire a light on the fire truck had been damaged and will need replacing.

PUBLIC WORKS, WATER AND WASTE WATER OPERATIONS; Public Works Director Ross Hewell was not present for the meeting but was informed by City Manager Jerry Elkins that Ross had returned to work after being out following surgery, he also stated that 80% of the roadside beautification project is complete.

BUILDING AND ZONING OPERATIONS; Building and Zoning Director Larry Krul was present and informed the Commission that he had gotten drawings for the 5 bungalows that are to be built at the Valhalla Resort. He informed the Commission that his last day on the job would be May 12, 2017 and that he had accepted a job working with the State. Commissioner Jeff Ash stated the appreciated the job that Larry had done for the City and will be sorry to see him go. City Manager Jerry Elkins stated that he had talked with Wayne Polston and Tom Obryant from White County and they had agreed to do inspections for the City until a replacement is found and that some of the discussion for the Executive would cover more detail.
