The Helen City Commission met on Tuesday April 16, 2013 at 3:00 p.m. in the Commission Chambers at Helen City Hall.

Mayor Lynn Whitener called the meeting to order at 3:00 p.m. City Clerk Marilyn Chastain called the roll and the following were present: Commissioner Judy Holloway, Commissioner Helen Wilkins, Mayor Lynn Whitener, and Commissioner Dona K Burke. Absent was Commissioner Jeff Ash. Also present were City Manager Jerry Elkins, Finance Officer Debbie Gerchman, City Attorney Carl Free, Police Chief Jim Couch, Building and Zoning Administrator Randy DeShon, Public Works Director Ross Hewell, Fireman Lee Potete, and City Clerk Marilyn Chastain.
