Administrative

A. Financial Report; City Manager Jerry Elkins went over the report with the Commission and reported that Hotel/Motel taxes are up as well as Sales Tax, and that financially everything is looking good.

- B. Discussion for Approval of City Hall bank restoration project; City Manager Jerry Elkins informed the Commission about the project. Motion to approve starting the project and allow the City to spend up to \$20,000.00 then to evaluate any additional cost made by Commissioner Jeff Ash, 2nd by Commissioner Cinnamon Spurlock. Motion approved with a unanimous vote of the Commission.
- C. CONSIDERATION FOR THE PURCHASE OF A SEWER JETTER THRU FUNDING GEFA; City Manager Jerry Elkins explained to the City Commission the Willow Pond Sewer project came in under the original project projection approximately \$82,000 and the additional GEFA funds could be used for an additional Sewer project or to purchase safety equipment or other equipment for maintenance and upkeep of the sewer system. Motion to purchase the Sewer Jetter up to a cost of \$75,000.00 made by Commissioner Judy Holloway, 2nd by Commissioner Helen Wilkins. Motion approved with a unanimous vote of the Commission.
- D. Consideration of Ground-Water Services, Inc. doing a Geophysical Survey for a new well site. City Manager Jerry Elkins told the Commission the Survey would be to find a location for a new well site. Mayor Fred Garmon stated with all the new Hotels being built that more water would be needed. Motion to approve made by Commissioner Helen Wilkins, 2nd by Commissioner Cinnamon Spurlock. Motion approved with a unanimous vote of the Commission.
