The Helen City Commission met on Tuesday November 16, 2021 in the Commission Chambers at Helen City Hall with Mayor Lee Landress calling the meeting to order at 10:00 a.m. City Clerk Marilyn Chastain called the roll and attending were Commissioner Jeff Ash, Mayor Lee Landress, Commissioner Steve Fowler, and Commissioner Fred Garmon. Absent was Commissioner Geneva Elwell.

City Clerk Marilyn Chastain stated that Hog Wild BBQ had also not been able to open in 2021 due to covid related delays and would like to consider them the same courtesy if approved. Commissioner Fred Garmon made the motion to approve letting the Alcohol license fee's already paid for 2021 be used for 2022 on both establishments, 2nd by Commissioner Jeff Ash. Motion approved with a unanimous vote of the Commission present.
