The Helen City Commission met on Tuesday, June 26, 2018 in the Commission Chambers at Helen City Hall with Mayor Jeff Ash calling the meeting to order at 10:05 a.m.

ROLL CALL BY DUPUTY CLERK MIRINDA DISPAIN: Present were Commissioners Steve Fowler, Commissioner Geneva Elwell, Commissioner Lee Landress, and Mayor Jeff Ash. Commissioner Cinnamon Spurlock arrived before the Executive Session.

Also attending were City Manager Jerry Elkins, Deputy Clerk Mirinda Dispain, Police Chief Brian Stephens, Fire Chief Jody Prickett, Building & Zoning Director Darrell Westmoreland, and Finance Officer Debbie Gerchman. Absent was Public Works Director Ross Hewell.

APPROVAL OF AGENDA: Motion to approve the agenda made by Commissioner Steve Fowler with the addition of the first reading of Ordinance 18-6-02 and an Executive Session for Personnel to be added after Number 11, 2nd by Commissioner Geneva Elwell. PUBLIC HEARING REGARDING FY 2018/2019 BUDGET: Motion to go into Public Hearing regarding the FY 2018/2019 Budget at 10:10 a.m. made by Commissioner Steve Fowler, 2nd by Commissioner Geneva Elwell. ORDINANCE 18-5-01 SECOND READING: ORDINANCE 18-5-01 AN ORDINANCE OF THE CITY OF HELEN, GEORGIA TO AMEND THE OFFICIAL CODE OF THE CITY OF HELEN, GEORGIA, BY THE AMENDMENT OF CHAPTER FOURTEEN OF THE HELEN MUNICIPAL CODE: BUSINESSES; BY THE REPEAL OF THE PRIOR ARTICLE V; AND IT'S REPLACEMENT WITH ARTICLE V: HOTELS OR MOTELS: City Manager Jerry Elkins explained all public concerns stated in the previous meeting had been changed in the ordinance. There were no other questions or comments. Motion to repeal and replace Chapter Fourteen, Article V of the Official Code of the City of Helen made by Commissioner Geneva Elwell, 2nd by Commissioner Steve Fowler. Motion approved with a unanimous vote of the Commission.

CONSIDERATION FOR APPROVAL OF THE INTERGOVERNMENTAL AGREEMENT FOR THE 2020 SPLOST: Mayor Jeff Ash explained that the current SPLOST would expire in 2020. This agreement outlines the distribution of the SPLOST which would be from 2020 until 2026 if the citizens of White County voted to approve the tax. The City of Helen and Cleveland would receive 20% each and White County would receive 60% of the amount of tax collected. Motion to approve the agreement made by Commissioner Lee Landress, 2nd by Commissioner Geneva Elwell. Motion approved with a unanimous vote of the Commission.

UPDATE ON THE PROCESS OF CALLING FOR A REFERENDUM FOR THE BRUNCH BILL TO ALLOW ALCOHOLIC BEVERAGES TO BE SERVED ON SUNDAY FROM 11:00 A.M. TO 12:00 A.M. (MIDNIGHT): Mayor Jeff Ash explained the process which would take place on Election Day, November 6, 2018.

CONSIDERATION OF ALLOWING PEDAL BIKE TOURS: Business Owner Chris Holloway explained the business. Each bike would have a pilot on board. Each patron would sign a waiver acknowledging rules for safety. He stated there would be no advertising on the bike except for his business name and phone number.

BY AN AMENDMENT TO ARTICLE III, HOTEL-MOTEL EXCISE TAX; SECTION 62-51 LEVY: The ordinance would extend the 8% Hotel-Motel tax from 10 days to 30 days of a motel-hotel stay (as now allowed by the State of Georgia). Motion to approve the first reading of the amendment to Ordinance 18-6-02 made by Commissioner Lee Landress, 2nd by Commissioner Steve Fowler. Motion approved with a unanimous vote of the Commission.

Catherine Cleiman owner of the Helendorf Motel asked for the procedure for allowing someone to stay at a hotel/motel longer than the 30 day limit. Motion to approve the long-term resident of the Helendorf Motel to continue his occupancy made by Commissioner Steve Fowler provided his information is given to the Police Department, 2nd by Commissioner Geneva Elwell. Motion approved with a unanimous vote of the Commission.
