The Helen City Commission met on Tuesday September 3, 2013 at 10:00 a.m. in the Commission Chambers at Helen City Hall.

Mayor Lynn Whitener called the meeting to order at 10:00 a.m. City Clerk Marilyn Chastain called the roll and the following were present: Commissioner Judy Holloway, Commissioner Helen Wilkins, Mayor Lynn Whitener, Commissioner Dona K Burke, and Commissioner Jeff Ash.

Also present were: City Manager Jerry Elkins, City Attorney Carl Free, Police Chief Jim Couch, Fireman Lee Poteat and City Clerk Marilyn Chastain.

Motion to approve the Agenda made by Commissioner Dona K Burke, 2<sup>nd</sup> by Commissioner Judy Holloway.

Administrative Operations.

A. Consideration for approval of the renewal of Contract with the Alpine Helen/White County Convention and Visitors Bureau. Motion to approve rental agreement for 1 year with the same terms made by Commissioner Jeff Ash, 2<sup>nd</sup> by Commissioner Helen Wilkins.

Motion approved with a unanimous vote of the Commission

B. Fletcher Holiday with EMI informed the Commission that there had been 2 bids submitted for the Island Area Project from Square Deal and Dodd Construction with Square Deal submitting the lower bid and recommended awarding the bid to them. A copy of the letter from EMI and a copy of the Notice of award will be made and integral part of these minutes. Commissioner Helen Wilkins made a motion to accept the bid from Square Deal and to give City Manager Jerry Elkins the authority to execute any documents necessary, 2<sup>nd</sup> by Commissioner Dona K Burke. Motion approved with a majority vote of the Commission, with Commissioner Jeff Ash abstaining.

Fletcher Holiday also said that Kim with EMI would coordinate the Ground Breaking Ceremony, and a date of October 15<sup>th</sup> at 2:00 p.m. was decided.

C. Fletcher Holiday with EMI also informed the Commission of a GEFA Grant for the water line extension and bridge crossing on Hamby Street as well as the new ground water well on Chattahoochee Street. Estimated total project cost is \$413,490.00 with approved grant funding of 25% in the amount of \$103,373.00, the remainding funds of \$310,118.00 will be funded through the (DWSRF) at a low interest loan currently at 1.4%. A copy of the letter from EMI and the Preliminary Cost Estimate will be and integral part of these minutes. Motion to authorize EMI to complete an official final application with all required attachments to include design plans and specifications made by Commissioner Jeff Ash, 2<sup>nd</sup> by Commissioner Judy Holloway.

Motion approved with a unanimous vote of the Commission.

D. Consideration for approval of additional street projects for the GDOT Local Improvement Maintenance Grant. City Manager Jerry Elkins informed the Commission that he and Public Works Director Ross Hewell had looked at the streets and think that the most needed locations are Brucken Strasse at Willow Pond, and Brucken Strasse at Chattahoochee Trails.

Motion to approve the proposed locations for improvement made by Commissioner Jeff Ash, 2<sup>nd</sup> by Commissioner Judy Holloway.

Motion approved with a unanimous vote of the Commission.

Discussion for consideration of Georgia Department of Transportation Speed Zone Ordinance. City Manager Jerry Elkins explained to the Commission that the speed zones and speeds were updated approximately every 2 years with GDOT for state highways, and that signing requirements must be met before any speed detection devices were used by the City. Motion to approve speed zones and speeds as listed on the agreement made by Commissioner Judy Holloway, 2<sup>nd</sup> by Commissioner Dona K Burke. Motion approved with a unanimous vote of the Commission.

Police Department Operations. Police Chief Jim Couch informed the Commission that they had a very active weekend and thought that all went well with the flow of traffic and that his department is preparing for the upcoming weekend street dance.

Public Works Department. City Manager Jerry Elkins stated that Ross Hewell is still doing well after his surgery, and that the Maintenance department had done a great job of cleaning up after the fireworks, also that Andrew Sims had really stepped up in getting needed jobs done during Ross Hewell absence.

## **Building and Zoning Operations**

A. Consideration and discussion of visible interior lighted signs. City Manager Jerry Elkins stated there had been several complaints on the amount of signs inside businesses that are visible thru the windows and that the PDRB had suggested limiting the size of open signs, limit of 1 sign with no blinking, cascading, or strobe types allowed. City Attorney Carl Free stated he would get ideas together for the next commission meeting.
