CITY OF HELEN COMMISSION MEETING AUGUST 14, 2018 MINUTES OF MEETING

The Helen City Commission met on Tuesday, August 14, 2018 in the Commission Chambers at Helen City Hall with Mayor Jeff Ash calling the meeting to order at 10:00 a.m.

ROLL CALL BY DEPUTY CLERK MIRINDA DISPAIN: Present were Commissioner Steve Fowler, Commissioner Geneva Elwell, Mayor Jeff Ash, Commissioner Cinnamon Spurlock, Commissioner Lee Landress.

Also attending were City Manager Jerry Elkins, City Attorney Carl Free, Deputy Clerk Mirinda Dispain, Police Chief Brian Stephens, Fire Chief Jody Prickett, Public Works Director Ross Hewell, and Building & Zoning Director Darrell Westmoreland.

PLEDGE OF ALLEGIANCE TO THE FLAG

APPROVAL OF AGENDA: Motion to approve the agenda made by Commissioner Lee Landress with the addition of Discussion of Adding Brick Pavers to the Front of City Hall for the Drainage Project under #7(E) and Discussion of Park Signage under #10, 2nd by Commissioner Cinnamon Spurlock. Motion approved with a unanimous vote of the Commission.

APPROVAL OF MINUTES FROM JULY 10, 2018 AND JULY 31, 2018: Motion to approve minutes from July 10, 2018 made by Commissioner Geneva Elwell, 2nd by Commissioner Lee Landress. Motion approved with a unanimous vote of the Commission. Motion to approve minutes from July 31, 2018 by Commissioner Cinnamon Spurlock, 2nd by Commissioner Geneva Elwell. Motion approved with a unanimous vote of the Commission.

PETITIONS AND COMMUNICATIONS FROM THE PUBLIC: There were none.

ADMINISTRATIVE OPERATIONS

A. DISCUSSION AND CONSIDERATION OF POSSIBLE CHANGES TO THE TUBING ORDINANCE: Teri Sims with Cool River Tubing brought a number of items to show the Commissioners which she would like them to consider approving for use on the Chattahoochee River. Items included metal drink containers, waterproof pouches and hooks to attached items to the tubes. She believed these items would limit the trash in the river, but accommodate the needs of the City's visitors. Because of the amount of options, Mayor Jeff Ash asked that a committee be formed to evaluate the choices and return to the Commission with recommendations, he also suggested Commissioner Steve Fowler be chairman, Commissioner Cinnamon Spurlock be on the Committee, Building Director Darrell Westmoreland also be on the committee

along with a representative from each of the tubing companies. Motion to approve the creation of a committee to discuss ordinance changes to the

current Tubing Ordinance made by Commissioner Steve Fowler, 2nd by Commissioner Geneva Elwell. Motion approved with a unanimous vote of the Commission.

B. DISCUSSION CONCERNING 4TH OF JULY FIREWORKS: The Police, Fire and Public Works Departments agreed there were no public safety concerns around the Fourth of July fireworks show. The Commission determined to continue the 4th of July firework celebration, but to limit the contract with the pyrotechnics to one year with a release clause in the event the launching property becomes unavailable.

C. UPDATE FROM COMMISSIONER SPURLOCK ON FALL AND CHRISTMAS DECORATIONS. Commissioner Cinnamon Spurlock presented the Commission with the beginning and completion dates for the seasonal decorations. There was a request for the decorations to remain up through January. The Holiday Outdoor Lighting Ordinance would be reviewed.

Motion approved with a unanimous vote of the Commission.

E. CITY MANAGER UPDATE OF PROJECTS: City Manager Jerry Elkins gave an update on the Well Project, the Hardman to Helen Trail, and the City Hall Drainage Project. Commissioner Lee Landress made the motion to allow brick pavers to replace pavement destroyed during Drainage Project in front of City Hall, and to permit City Manager Jerry Elkins to obtain proposals and accept the best value for pavers, 2nd by Commissioner Cinnamon Spurlock. Motion approved with a unanimous vote of the Commission.
