City Manager Jerry Elkins stated he had sent a letter last week to the business owners reminding them of the Christmas light ordinance and of the upcoming pedestrian bridge construction.

Mayor Helen Wilkins stated that at the next Commission meeting that the tubing company owners were to be there to discuss how to better keep the river clean.

POLICE DEPARTMENT OPERATIONS; Police Chief Brian Stephens stated the Halloween carnival had gone great and that there had been 250 to 300 children that attended, that the annual golf tournament had a large turn out, and also that the 2nd car show had been great and thanked all that had participated and donated. He stated they would start taking applications soon by the families for the White Christmas.

FIRE DEPARTMENT OPERATIONS; Fire Chief Jody Prickett stated they had been doing Hose testing for 2 weeks, and stated that due to the County renumbering some stations truck 31 would need to be changed with the cost being made by the county.

PUBLIC WORKS, WATER AND WASTE WATER OPERATIONS; Director Ross Hewell stated they had gone from cleaning after Oktoberfest to hanging Christmas Lights and were very busy, and that they were unable to move some of the Christmas fixtures as requested due to not having an adequate electrical supply at the locations.

BUILDING AND ZONING OPERATIONS; Director Darrell Westmoreland stated he had done multiple inspections and would restart the Hotel inspections now that the Oktoberfest was over and that so far the owner that needed to do repairs had done what he had been told that needed doing.
