## CITY OF HELEN COMMISSION MEETING NOVEMBER 12, 2019 MINUTES OF MEETING

The Helen City Commission met on Tuesday November 12, 2019 in the Commission Chambers at Helen City Hall with Mayor Cinnamon Spurlock calling the meeting to order at 10:00 a.m.

ROLL CALL BY CITY CLERK MARILYN CHASTAIN; Present were Mayor Cinnamon Spurlock, Commissioner Jeff Ash, Commissioner Steve Fowler, Commissioner Geneva Elwell, and Commissioner Lee Landress.

Also attending were City Manager Jerry Elkins, City Attorney Carl Free, City Clerk Marilyn Chastain, Finance Officer Mona Wood, Police Captain Mark Harris, Fire Chief Jody Prickett, Public Works Director Ross Hewell, and Building & Zoning Director Darrell Westmoreland.

## PLEDGE OF ALLEGIANCE TO THE FLAG

APPROVAL OF AGENDA; Motion to approve made by Commissioner Steve Fowler, 2<sup>nd</sup> by Commissioner Lee Landress. Motion approved with a unanimous vote of the Commission.

APPROVAL OF MINUTES FROM OCTOBER 8, 2019 AND OCTOBER 23, 2019 COMMISSION MEETINGS; Motion to approve made by Commissioner Steve Fowler, 2<sup>nd</sup> by Commissioner Geneva Elwell. Motion approved with a unanimous vote of the Commission.

Petitions and Communications from the Public; Resident and Planning, Design & Review Board member Linda McAllister stood and addressed the Commission by asking the status of what is happening with the previous discussion of improvements to the playground equipment, lighting, sidewalks, and public restrooms at Pete's Park. She then stated she is proud of the Christmas decorations and the attention they are getting, but that she was unaware that the installation of the decorating had been put out for bid or discussed at a public meeting and wanted it put on record that she is concerned that the Commission is being not being transparent about decisions being made in an open meeting.

Mayor Cinnamon Spurlock stated her prior hopes for Pete's Park were to include restrooms, sidewalks, and playground equipment.

Phyliss Hann spoke in favor of new restrooms at Pete's Park.

Commissioner Jeff Ash stated that the Helen Hill and restrooms behind the Arts Center had been neglected and needs to be cleaned up, and that the concerns were points well taken, that getting the Christmas lights up has been hard for 15 years and does have people working on them but to please understand that the city has recently lost 3 employees that normally helps in the installation of the decorations.

Mayor Cinnamon Spurlock wanted to thank the Bridge Church for sending a large group of church members to Helen to do a litter pick-up.

Joel Cauldwell of Alpine Trains asked to have consideration of a change to his route to include being allowed to turn into Paul's Steakhouse to pick up patrons and then to reenter the highway turning left from Paul's parking lot. Motion from Commissioner Jeff Ash to approve after receiving a letter from RT Turner stating that he is giving permission for the train to pick up from there and after review for approval from the Police Chief, 2<sup>nd</sup> by Commissioner Steve Fowler. Motion was approved. Mayor Cinnamon Spurlock stated she has a safety concern allowing a left turn.

Chris Seymour of Alpine Carriage asked the Commission to extend the time on allowing the Carriages to use the City property until the Martin Luther King holiday on January 21, 2020 stating they are having a difficult time finding property to lease for the Carriage rides. Commissioner Jeff Ash made a motion to approve extending the Occupational Tax certificates and regulatory fees thru January 21, 2020, 2<sup>nd</sup> by Commissioner Lee Landress. Motion approved with a unanimous vote of the Commission.
