#### ADMINISTRATIVE

A. FINANCIAL REPORT; City Manager Jerry Elkins stated the financial report looks good and that the City is in good shape financially with revenues up compared to this time last year and expenses down. B. Motion approved with a unanimous vote of the Commission.

Police Chief Brian Stephens gave a verbal report as well, he then thanked Commissioner Cinnamon Spurlock and Rob Moore from Access North Georgia News for their help in shopping for the White Christmas.
