CITY OF HELEN COMMISSION MEETING MAY 14, 2020 MINUTES OF MEETING

The Helen City Commission met on Thursday May 14, 2020 in the Commission Chambers at Helen City Hall with Mayor Steve Fowler calling the meeting to order at 10:00 a.m. Attending were Commissioner Jeff Ash, Commissioner Geneva Elwell, Mayor Steve Fowler, Commissioner Lee Landress, and Commissioner Fred Garmon.

Also attending were Finance Officer Mona Wood, City Manager Jerry Elkins, City Attorney Carl Free, City Clerk Marilyn Chastain, Police Chief Brian Stephens, Fire Chief Jody Prickett, Building & Zoning Director Darrell Westmoreland. Absent was Public Works Director Ross Hewell.

- B. 2020 2021 FISCAL YEAR BUDGET; Commissioner Jeff Ash made motion to abide by the required budget process and to consider setting the new 2020/2021 budget using the 2019/2020 figures and amending after the first 90 days after figures are updated due to the uncertainty of what revenues will be received during the pandemic, 2nd by Commissioner Lee Landress. Motion approved with a unanimous vote of the Commission.
- C. UPDATE FROM CITY MANAGER ON CURRENT PROJECTS; City Manager Jerry Elkins stated that next week the Innsbruck water tank will be down for maintenance and that EMI is to start the smoke testing on the sewer lines, and the concrete water tank project is on-going.

D FINANCIAL REPORT; Finance Officer Mona Wood gave an update on the City's Finances. Motion to approve made by Commissioner Jeff Ash, 2nd by Commissioner Fred Garmon. Motion approved with a unanimous vote of the Commission.

E DISCUSSION OF HORSE CARRIAGE RIDES; Mayor Steve Fowler explained that the additional route that had been approved on a trial basis had expired. Chris Seymour of Alpine Carriage was present and asked the Commission to allow the route to continue to operate. Motion to approve the continued use of the southern route that was previously approved for 60 days at the February Commission meeting until problems arise made by Commissioner Fred Garmon, 2nd by Commissioner Geneva Elwell. Motion approved with a majority vote of the Commission. Mayor Steve Fowler was opposed.

City Manager Jerry Elkins stated the GDOT project to replace the drainage pipe at the Chevron station is planned to start next week.

HELEN CHAMBER OF COMMERCE MONTHLY REPORT; Report included as an integral part of the Minutes. Director Renee Green was present and gave a verbal report and stated that Bingo is to start June $1^{\rm st}$ and that so far Oktoberfest is a go!

HELEN/WHITE COUNTY CVB MONTHLY REPORT; Report included as an integral part of the Minutes. Director Jerry Brown was present and gave a verbal update and stated they are planning on reopening the Welcome Center to the public on June 12th and that financially they are doing well, that he had not done any extra advertising during the month because of the pandemic.

POLICE DEPARTMENT OPERATIONS; Report included for March and April as an integral part of the Minutes. Police Chief Brian Stephens was present and gave a verbal report of March and April.

Building & Zoning Director Darrell Westmoreland stated the paving at Fairfield Inn should start Monday and when complete they are approved to open. The concrete slab has also been poured for the Conference Center there.
