The Helen City Commission met on Tuesday May 8, 2018 in the Commission Chambers at Helen City Hall with Mayor Jeff Ash calling the meeting to order at 10:00 a.m.

UPDATE FROM CITY MANAGER JERRY ELKINS ON CURRENT CITY PROJECTS; City Manager Jerry Elkins informed the Commission that he is working with GDOT on the final closing out of the Pedestrian Bridge project, that the City should be finished with the landscaping portion at the Helen to Hardman farm trail within the next 10 days that the State would not allow the City to do their part until they had completed the state portion. He stated that the statue for the Veterans park should be delivered to Savannah 1 week prior to the dedication and that members of the Veterans group would be picking it up for installation. He also commended the public works department for their hard work on getting the work done at the Veterans park. Also discussed is the bid opening for the water line replacement and well project that should be in about 5 weeks, with construction to start in July or August and the grant for the project is \$300,000 from USDA and the total cost to be approximately \$750,000.

Public Works Director Ross Hewell stated his department is short handed at the moment with 1 employee out recovering from hip surgery, 1 in the hospital, and one no longer with the department so things are getting done but being short handed has slowed things down and asked for patience. He stated that he is waiting on part to come in to finish installing the street lights north of Betty's and at the Helen to Hardman Trail.
